**Appointment of Committee of Inquiry into allegations made by the "Channel-4" Television Programme**

Allegations have been made by the television programme titled "Sri Lanka's Easter Bombings - Dispatches" broadcast by the British television channel "Channel -4" on September 05, 2023 to the senior government military intelligence official and certain politicians of Sri Lanka that they had connections with suicide bombers of the Easter Sunday Bomb Attacks on April 21, 2019.

02. Therefore, the Hon. President has deemed it necessary to appoint a Committee of Inquiry to inquire into and report on whether the persons, who have been alleged by the aforesaid television programme, had engaged in any act or omission in relation to the Easter Sunday Bomb Attacks and complicity with the suicide bombers of the Easter Sunday Bomb Attacks.



Sir,

I wish to acknowledge the receipt of your letter dated 6 October 2023, transmitted on 18 October 2023.

In that letter you have requested confirmation of the factual correctness of the statement made in a media broadcast that Mr HA Moulana "has presented sworn testimony to the United Nations Human Rights Council". The Office of the High Commissioner for Human Rights ("the Office") has no knowledge of any submissions made directly to the Human Rights Council.

However, through resolutions 46/1 and 51/1 on "Promoting reconciliation, accountability and human rights in Sri Lanka", the Human Rights Council "recognize[d] the importance of preserving and analysing evidence relating to violations and abuses of human rights and related crimes in Sri Lanka with a view to advancing accountability" and decided to strengthen in this regard the capacity of the Office of the High Commissioner for Human Rights "to collect, consolidate, analyse and preserve information and evidence and to develop possible strategies for future accountability processes for gross violations of human rights or serious violations of international humanitarian law in Sri Lanka, to advocate for victims and survivors, and to support relevant judicial and other proceedings, including in Member States, with competent jurisdiction".

In relation to the work being carried out by this Office pursuant to these Human Rights Council resolutions, we have no information pertaining to your request for which we have consent to share with your Committee of Inquiry.

The High Commissioner hopes the investigation into the Easter Sunday bombings will pursue all lines of inquiry, with the full participation of victims and their representatives. Our office remains ready to engage further on this matter and will study carefully your Committee's findings and recommendations.







Channel 4 is committed to upholding the highest standards of journalism and journalistic freedom. It is central to those principles that we do not agree to reveal the confidential sources for our programmes or to disclose confidential journalistic material. Providing such information would undermine the willingness of individuals to co-operate with journalists, discourage journalists from disseminating information that it would be in the public's interest to know and weaken the actual and/or perceived neutrality of journalists.

For the above reasons, Channel 4 respectfully declines your invitation to appear before the Committee. The content of the Programme speaks for itself and Channel 4 has nothing to add beyond the details set out therein.





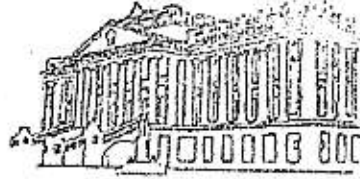

Hello, good evening and welcome. It was a momentous day for all of Sri Lanka. Promising changes to ensure good governance and democracy, Maithripala Sirisena was elected as the sixth...

**18.15 (Channel 4-news)**

In January 2015, a new president finally ousted the Rajapaksas from power, promising to bring a new kind of politics to Sri Lanka.

**Title: Undisclosed Location**

• For 20 years, Nishanta Silva was one of Sri Lanka's top policemen. When the Rajapaksas lost power, he was tasked by the new government with investigating human rights abuses during their time in office. He has given testimony to European intelligence agencies and the People's Tribunal at The Hague. This is the first time he has told his story to the media.

**18.52 - Nishantha Silva interviewed by Channel 4**

- Why are you not in Sri Lanka?

**Nishantha Silva – Former Police Inspector, CID**

- I got a death threat to me and my family from the army intelligence, navy intelligence and the former president, Gotabhaya Rajapaksa.

**19.10 - News 1<sup>st</sup>**

- The criminal investigations department presented facts pertaining to the assassination of journalist Lasantha Wickramatunga to the Mount...

**19.15 - (Channel 4-news)**

Nishantha Silva's key case was the killing of newspaper editor, Lasantha Wikramatunga. What he found led him to the notorious Tripoli platoon.

**19.24 - Mr. Nishantha Silva**

I was able to get a glimpse of their history. I have discovered information that 5 phones taken by members of the Tripoli group are related to their actions in the killing of journalist Mr. Lasantha Wickramatunga.

The evidence showed that members of the Tripoli platoon followed Lasantha from his home to the location where he was killed. For years, many people had suspected that Gotabhaya Rajapaksa was behind the killing. But Nishantha was the first person to analyze the telephone records and find evidence to back up that claim.

**20.11 - Mr. Nishantha Silva**

Translated to English - Gotabaya Rajapaksa had direct supervision regarding the Tripoli Platoon. I called Gotabhaya to the Criminal Investigation Department for questioning.

Powerful figures still loyal to the Rajapaksas stalled Nishantha's investigations from courts. But further allegations against the family continued to mount.

Mahinda Rajapaksa, the former president, was called in for questioning on corruption charges.

21.14 - Hon. Mahinda Rajapaksa

#### 21.40 - Ada Derana News

- The CID said that Chandrakanthan was arrested over the murder of former parliamentarian Joseph Pararajasingam.

#### 21.48 (Channel 4-presenter)

- In October 2015, police charged Pilleyan with the murder of an anti- Rajapaksa politician at a midnight mass service in 2005. Pilleyan was remanded in prison to await trial. (video footage shows Pillayan walking with Mr Gazali Hussain to CID)

September 2017 – 19 months before the Easter Bombings – Batticaloa, Eastern Sri Lanka

#### 22.15

- Pilleyan was imprisoned in his hometown of Batticaloa. He remained a politician and a powerful local figure, so was granted special privileges. Maulana told UN investigators that Pilleyan called him to a meeting from his cell.

#### 22.30 - Mr. Maulana

- Pilleyan told me, I have some prisoners with me, but they are very interesting people. They are very extreme. He is saying, meet one person. So one prison guard walked a person was a dark person with beard. I say salam, he says salam. The Muslims greeting, assalamu alaykum. His name Zaini Maulavi.

**Subtitles:** Pilleyan told me, I have some prisoners with me, but they are very interesting people, they are very extreme. He says "you should meet one person. So one prison guard brought a person. He was a dark person with a beard. I say Salam and he say Salam. Muslims greeting Salam Aleikkum. His name Shaini Maulawi

#### 23.01 - (Channel 4-presenter)

Zaini Hashim Maulavi was being held in prison on charges of religious extremism. His brother Zahran, who was in hiding, had been recruiting followers for National Tawheed Jamaat or NTJ. The NTJ were an Islamic extremist group who wanted to turn Sri Lanka into a caliphate.

#### 23.17 – Mr.Mohamed Zaharan Video (Tamil)

**Subtitles:** people ask "how can you kill innocents", there is no such thing as innocent people.

Mr Maulana

According to Maulana, on Pilleyan's orders, he found the men a lawyer and money for bail. They were released and three months later, Maulana says he received more instructions.

**23.52 - Mr. Maulana**

In January of 2018, Pilleyan told me, you organize a meeting between Suresh Salley and these people.

**Subtitle: same as above 24.03 - Mr. Suresh Salley**

Good afternoon everybody. It is indeed a great privilege and honor for me to address this distinguished audience. [Sri Lanka Army video]

**24.10 - (Channel 4-presenter)**

Suresh Salley is a soldier who became a spy. The Rajapaksas championed his career, quickly promoting him through the ranks to become the Director of Military Intelligence. After the Rajapaksas lost the 2015 elections, Suresh Salley was posted to Malaysia by the new government. He was still seen as fiercely loyal to his former bosses and maintained huge influence behind the scenes. Few people in Sri Lanka are willing to talk about one of the country's top spies, but this program secured a rare interview with another high-ranking former government official, who knows how he operates from the inside. He was only willing to discuss Suresh Salley anonymously.

**24.52 - Unknown government official**

25.25 - Mr. Maulana

The exact location name is Karadipuwal. After that I gave the information to the group to come to place. That's why I knew everything. I go to the place, a big coconut farm. One horse is there.

25.42 - (Channel 4-presenter)

Maulana says intelligence officer Suresh Salley was there when he arrived and that they waited for the NTJ members to turn up. They come a white van.

25.58 - Mr. Maulana

Six people get off from the vehicle. Zaini Maulavi come and shake the hand and hugged and say Salam after that introducing his brother Zaharan. And he says he's our Amir, Amir mean Muslim called leader. So I introduced Suresh Salley to them.

Subtitle: they come in a white van. Six people got out from the vehicle. Zaini Moulawi came and shake the hand. He hugs me and says Salam. After that he introduced his brother Zaharan. And he says "he is our AMir" Amir means in Muslim (in Islam) leader. So I introduce Suresh Salley to them.

26.15 - (Channel 4-presenter)

According to Maulana's testimony to the UN this was the moment he introduced one of Sri Lanka's most senior intelligence officers to the head of a known terror group. Maulana told UN investigators the meeting lasted three hours and he was told to wait outside.

26.34 - Mr. Hanzeer Maulana

- The meeting go on long time. And meeting finish and Suresh Salley told me "Rajapaksas need unsafe situation in Sri Lanka. That is only the way to Gotabhaya become president. So this is the meeting between them, the terrorist group and Suresh Salley.

- Suresh Salley told this program that he was in Malaysia at the time of the alleged meeting. By the end of 2018, Zahran's group the NTJ was beginning to make headlines.

27.01 - (Channel 4-presenter) News 1<sup>st</sup>

- The bodies of two police officers who were on duty at a roadblock in Batticaloa have been found under suspicious circumstances.

Channel 4 - presenter

The NTJ killed two policemen but managed to escape. Then by January 2019, police investigations led them to a safe house on a coconut farm.

Moulana says it was the same place where Suresh Saleh met with Zahran and the NTJ. When detectives raided the property, they made an alarming discovery.

27.35 - muffled voice

When they were questioned we found out that the safe house or training base was run by their leader Zahran and that they were members of the NTJ group.

28.09 - (Channel 4-news)

They had enough information to arrest Zahran and his NTJ followers.

But at every turn, police investigators ran into brick walls. [5<sup>TH</sup> December 2018 Letter of Directorate of Military Intelligence is shown]

Our whistleblower can confirm that while police tried to track down the leader of the terrorist group, military intelligence was producing evidence which police investigations would later reveal to be baseless.

These conflicting and unfounded intelligence reports seen here show that Sri Lanka's military intelligence tried to stifle the investigation at every turn.

#### 28.45 - Unknown voice

- Rumours of a pending terror attack had even made it abroad. Two weeks before the bombings India's intelligence services warned their

Sri Lankan counterparts that Zaharan was planning an attack.

11 April 2019 – [letter TITLED "information of an alleged planned attack" from special security range division, IGP office to D/MSD, JSD, RPSD IV, RPSD V, Diplomatic security division

- When a top police official read the warnings, he tried to raise the alarm and wrote a memo, seen here, to the security services. {foreign intelligence agencies have informed that these attacks could target Catholic churches} The intelligence even specified Catholic churches as possible targets. But shortly after the attacks, top government officials said the warnings never reached them, nor the president.

**30.11 – Mr. Sudesh Kolonne**

Title: Sri Lanka's Easter Sunday Bombings – Dispatches 2019 Easter Sunday

My daughter, she spends most of the time with me. She likes to create the songs and we sing together. She plays guitar all the time and the pianos and we play together. Yes, all the time. I do everything for her. Take her to the school, take them back home. Home works together and I play together.

**30.31 - (Channel 4-presenter)**

Sudesh Kolonne and his daughter Alexandria were inseparable. In 2019, he and his wife Manik had recently returned to Sri Lanka after more than two decades living in Australia.

The couple wanted to raise their daughter in their homeland alongside their extended families. Sudesh is a Buddhist, but on special occasions he would join his wife and daughter at their local church, St. Sebastians.

**30.56 Mr. Sudesh Kolonne – a victim**

- That day was quite special because my daughter and wife, they are very excited. They are celebrating Easter Sunday as Catholics. They really want to go to the church.

**31.16 - (Channel 4-news)**

- That same morning, almost 200 miles away on Sri Lanka's eastern coast, Moulana says he received an unexpected phone call from Suresh Salley.

**31.24 - Mr. Maulana**

Suresh Salley called me actually.

He just say, immediately you can go to the Taj Samudra Hotel. A person waits for you, come out, you take him into your vehicle immediately. Once you take, you take his phone. After that, ask him where he can go and drop him. This way he gave instructions to me. • But I told, sir, I was in Batticaloa.

Subtitles: He just said "immediately you can go to the Taj Samudra Hotel, a person wait for you, come out you take him into your vehicle immediately once you, you take his phone. After that ask him where he can go and drop him" This is what he instructed to me. But I told "Sir, I am in Batticaloa"

**31.46 - (Channel 4-presenter)**

Around the same time in the capital Colombo CCTV from the Taj Samudra Hotel showed a member of Zahran's NTJ group in the restaurant at 8.50 a.m. He was wearing a backpack laden with explosives. Hanzeer says he now believes that this was the man who Suresh

Salley had asked him to meet there. The would-be attacker then received a phone call. Two minutes later, he leaves the hotel without detonating his bomb. Back in St. Sebastians, the Easter service was coming to an end.

#### 32.29 Mr. Sudesh Kolonne, victim

That day I parked my car outside the church.

A lot of people for the Easter Sunday, quite packed the church that day. When the end of the ceremony and my wife said to me, you go and get the vehicle and we come outside.

#### 32.42 - (Channel 4-presenter)

- As Sudesh stepped outside to collect his car, another worshipper, Niranjali, her husband and two daughters and another worshiper, had just returned to their seats after receiving Holy Communion.

#### 32.52 - A lady victim \_ Niranjalee Yasawardana

- The time read 08.46. The bomb exploded at the same time with a huge noise. With that noise, I could not speak or open my eyes. I fell.

**Subtitles:** I remember that the time on the clock was 8.46am. Right after there was a loud noise and that is when the bomb exploded. After the explosion I couldn't speak or open my eyes, I fell on the ground

#### Channel 4 - presenter

- Sudesh was still outside.

#### 33.22 - Mr. Sudesh Kolonne

- A huge noise and a cluster of smoke everywhere. I was crying and screaming and running around to find my wife and daughter. The bodies are everywhere. It was unreal. First of all I saw my daughter on the floor. I mean she was already dead. It was quite an unbelievable experience.

#### 34.14 - ( Channel 4-news)

- Sudesh lost both his wife and daughter in the blast. Niranjali was covered in debris as she lay on the ground.

#### 34.23-Lady victim

- I saw my youngest daughter and older daughter who had fallen at my feet. Their eyes open but when I saw my younger daughter my heart told me that she was no longer alive.

34.49 - (Channel 4-presenter)

Her husband and older daughter were still alive and were taken to hospital.

Both later died from their injuries.

In total, 115 people were killed at St. Sebastian's church, including 27 children. Almost simultaneously, five other bombs had gone off around the country. Two other churches were hit, St. Anthony's in Colombo and the Zion in Batticaloa. Bombs also struck three luxury hotels along Colombo's seafront.

The Cinnamon Grand, the Kingsbury. Group leader Zahran targeted the Shangri-La Hotel with another bomber. British teenagers Amalie and Daniel Lindsay were killed while on holiday with their father. Another Brit, 43-year-old Ben, was the only surviving member of the Nicholson family. An 11-year-old American, Kieran de Zoysa, was killed at the Cinnamon Grand Hotel as he ate breakfast with his mother and grandmother. Danish billionaire Anders Polsen and his wife, Anne, lost three of their four children at the Shangri La Hotel. A seventh explosion took place at the Tropical Inn, a small hotel in central Colombo at around 2pm, killing the bomber and two others. The attacker was the man who had left the Taj Samudra hotel that morning. By the end of the day, more than 250 people had died.

In the days after the Easter bombings, police raided several addresses across the country. At one, they located the group leader Zaran Hashim's brother, Zaini, the man whom Hamzia said he had met in prison. As soldiers prepared to storm the building, the family posted a defiant video online.

Zainee Hashim Maoulavi - Even if we are destroyed even if we are killed, it wont stop

When the army entered, they blew themselves up alongside their wives and children.

37.54 - Mr. Maulana

- After the Easter bomb happened, I realized the faces who were the participated the meeting. The first is the Zahran, a suicide bomber and a leader. So, I knew these people already; I met him. I am scared, then I talked to Pilleyan. He said, "You shut up your mouth. You don't know anything. That's it."

38.14 - (Channel 4-presenter)

Five US citizens had been killed at the seafront hotels, prompting FBI agents to begin their own investigations.

38.26 - Unknown voice

Our whistleblower says the Police were prevented from interrogating the suspect by military intelligence themselves. He says he's seen evidence pointing to the man pulling the strings, Suresh Saley, Gotabhaya Rajapaksa's most trusted confidant in the intelligence services.

39.10 Question – (Channel 4-presenter)

What role do you believe Suresh Saley may have played in the Easter bombings?

39.12 - Answer by unknown voice

Within days of the bombing , Gotabhaya Rajapaksa announced his political comeback. With his big brother Mahinda's support, he declared he was running for the presidency in elections that year.

39.54 - Mrs. Fedrica Jansz

- When I saw Gotabhaya was running for election in 2019, I wasn't surprised. I always, for a very long time, knew he would. This is a power- hungry individual,

40.04 - (Channel 4-presenter)

- Gotabhaya Rajapaksa's electoral platform was simple. He fomented a wave of Islamophobia so that now only he, the former defence secretary who had marshaled the defeat of the Tamils in the civil war, could keep the country safe from this new Muslim threat.

40.20 - Hon. Gotabaya Rajapaske (Sinhala)

- Sinhala speech translated in to English: "I say with confidence that we can once again make this the most secure country in the world."

40.32 - (Channel 4-presenter)

A little more than six months after the Easter bombings, Gotabhaya Rajapaksa was elected president of Sri Lanka with a thumping majority. Pilleyan and other Rajapaksa loyalists welcomed the family's return.

40.50 - Mr. Maulana

They did this murder because of his orders. They need him for power.

Subtitles: they did this murders because of his order, they need him in power.

40.56 - (Channel 4-presenter)

Almost immediately

- After taking office, Gotabhaya Rajapaksa derailed the investigation into the bombings.

Senior Government Official (unknown)

41.32 - (Channel 4-presenter)

Parliamentarian Sivanesathurai Chandrakanthan was granted bail by the Batticaloa High Court in the case filed...

Then in November 2020, Pilleyan was released on bail, and two months later, the charges were dropped.

When the presidential inquiry into the Easter attacks concluded, Gotabhaya Rajapaksa refused to release the report. "We have obtained a copy which reveals that the lead bomber was known to intelligence services for years before the attacks."

Ever since the bombings, the loudest voice calling for justice is the head of the Catholic Church in Sri Lanka, Cardinal Malcolm Ranjith.

He says he's seen evidence that shows government officials were behind the attacks and now openly calls for a truly independent investigation.

**42.22 - Father Malcolm Ranjith – Archbishop of Colombo**

- "People have a right to know, and we have a right to know because we lost our own people. And we will continue with this struggle until we know the truth."

Nevertheless, the former president returned to Sri Lanka just weeks later to lay low in Colombo's most exclusive neighbourhood, where he still resides.

The allegations in this program were put to Gotabhaya Rajapaksa and Pilleyan. They did not respond. Suresh Salli denies any connection with the Easter bombings and says he was in Malaysia at the time he is alleged to have met NTJ members, and in India at the time of the attacks.

He also said that he was not operative in the defense or security structure of Sri Lanka between January 2018 and the 2019 attacks.

For the families who lost their loved ones, many feel they still have no answers.

- "Why they killed my family? I really want to go and ask. That's the question I'm thinking to myself still.

**45.10 - A lady victim**

- My world is my children and in a second I lost it all. They will never be able to call me mother again.

- The whistleblowers' testimonies raise serious questions. 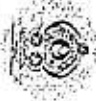


